02. The name of the Trust shall be- **BHARATIYA SANSKRITIK SURAKSHA SANGH,** Address- 57 MAA SARADA APARTMENT, NANDANKANAN PO- HINDMOTOR PS- UTTARPARA DIST- HOOGHLY PIN- 712233, West Bengal, India. Which is rented and which may be shifted from time to time to such other place or places as the Trustees may deem fit and proper at their discretion? The Trustees may if they so desire change the name of the Trust in future.

03. The objects of the Trust shall be - 1] To establish, promote, set up, maintain, assist, finance and or aid to or help in the setting up and or maintaining and or running schools and other institutions, Orphanages, Widow Homes, Old Age Home, lunatic asylums, poor houses, or other establishment for relief and or help to the poor, old and infirm people and or destitute.

2] To start, maintain, and assist any relief measures or those parts which are or become subjected to natural calamities etc. to set up, start and run urban & rural sanitation programme.

3]To establish and operate rehabilitation centers in various places in India for those treated and cured from the disease such as schizophrenia with a view to create confidence and hope in them and to provide an opportunity to them to learn,

14] To Conduct Consumer Protection Activities. To execute the Legal Aid support for the needy poor & helpless people.

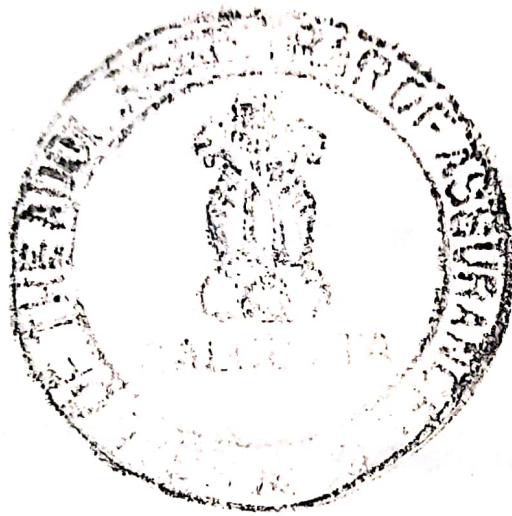

23] To impart job oriented vocational training and educational to all section of the society.

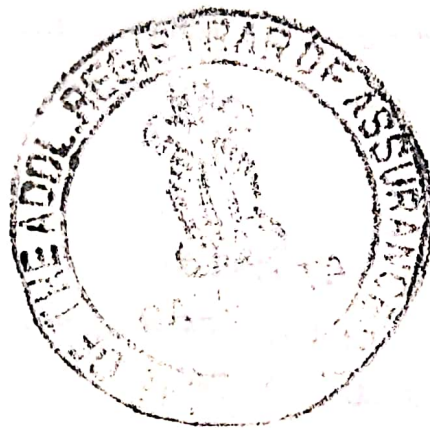

- Civil rights (such as the rights to life, liberty and security),

- Social rights (like rights to education and consenting marriages),
- Cultural rights (including the right to freely participate in their cultural community), and
- Collective rights (like the right to self-determination).

If any one or more of the objects specified in clause (3) of these presents are held not to be objects of public charitable nature, the TRUSTEES shall not carry out such object or objects as if the same are not incorporate in these present but the validity of the Trust created by these present as a Trust for public charitable purposes shall not be affected in any manner.

4. The financial year of the trust shall end on 31st March, every year provided that the Board of Trustees shall be at liberty to change the same from time to time if it so deem fit and proper. The first financial year of the Trust shall close on 31st March, 2015. The accounts will be audited every year after closing the financial year. But the quarterly inspection of the accounts is to be done and presented before the Trustees or Trustee if it is requested for.
5. The TRUSTEES shall form time to time after meeting the expenses of and incidental to the management of the Trust properties and of the Trust decide the particular object or objects for which the income or corpus of the TRUST FUND or properties for the time being available shall be applied.
6. The TRUSTEES may accept any donations or contributions in cash or in kind from any person, firm, company, corporation, association, institution or from another trust (including the settler or the trustees or any of them) for the furtherance of the objects of the Trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion thing fit and which are not inconsistent with the objects of the Trust. The TRUSTEES may also take over the management of any other charitable or public institutions on such terms as they think fit and may manage such institution.
7. Without affecting the generality of powers and functions of the TRUSTEES of the manage and administer the Trust, the board of TRUSTEES shall have the following functions.

- (a) To borrow if needed against the security of the asset of the Trust by way of bank overdrafts, loan or otherwise, as may be necessary for the benefit of the Trust and for more effectively carrying out the object of the Trust provided the trustees unanimously agree on such borrowings and limited to the terms of their decisions or agreement and to authorize one of the Trustees to execute such documents, deeds, papers etc. as may be necessary in connection therewith.
 - (b) To arrange for and or authorize the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the TRUSTEES by and one of the TRUSTEES to be nominated in this by the board of TRUSTEES and to make the same effective and binding as if said agreement, contract, instruments or document or paper or writing were signed by all the TRUSTEES.
 - (c) To appoint or make position for the appointment of a sub committee of the TRUSTEES and or other to attend to or supervise or conduct specified jobs are functions or trust matter in such manner and subject to such rules and regulations as the TRUSTEES may prescribe.
 - (d) To authorize any one more TRUSTEES to hold any property or any fund or any investment of the trust subject to the terms of these present in such manner and subject to such terms and conditions , rules and regulations as the board of TRUSTEES may form time to time think fit and proper.
 - (e) To spend any portion of the corpus or the income of the Trust fund for purchasing any land or constructing any building or buildings for and in the name of the Trust for the purpose of the carrying out promoting and or executing any or all the objects of the Trust.
9. The TRUSTEES shall cause true and accurate accounts to be kept of all money received and spent and for all matter in respect thereof in course of management



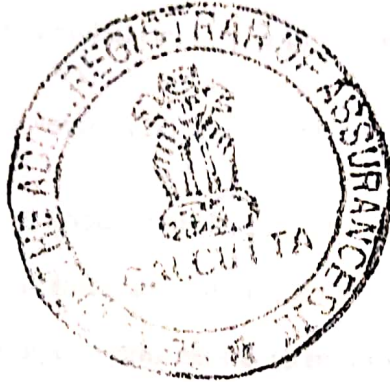

10. The TRUSTEES may invest the trust Estate either in the purchase or immovable properties or of mortgage of immovable properties or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investment from time to time provided that such investment shall not be made which are directly or indirectly for the benefit or the any person referred in the subsection (3) of section (13) of the income-tax act 1961, or any subsequent amendments as may be made from time to time .
11. If the income of the Trust property in a particular year is not fully utilized, the unexpanded income subject to the applicable provisions of the income-tax act 1961 shall be carried over to the next year or years and spent in subsequent year or years for the advancement of any of the objects of the Trust.
12. The area of operation of the Trust shall be all over India.
13. The Trust shall be at liberty to sell such portion or portions of the immovable movable properties forming part of the Trust estate either by public auctions or by private contract at such price or prices and or such terms and conditions relating to the title or otherwise in all respect as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasioned and to execute all conveyance thereby or other assurance and to pass valid and effectual receipts and discharge for all moneys received by them.
14. The TRUSTEES shall be entitled from time to open, maintain and operate Bank A/c. or A/cs in the name of the Trust any Nationalize or Private Bank. Any such account shall be opened and operated jointly by Chairman and any of the Trustees decided by the resolution. One or more Bank Account may be opened in any Bank and or Banks in the name of the Trust and provision should be there to open Bank accounts at the Head Office, State Office, Regional Office, Zonal

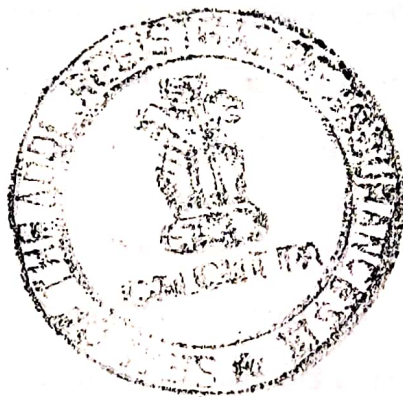
15. The Trustees may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the TRUST FUND, and may carry out repairs required to be done to the same and keep the same insured against loss or damage by fire and may incur all other costs, charges and expenses incidental to the administration and management of the Trust Estate and the properties for the time being belonging to the Trust as they may in their absolute discretion think fit.
16. The Trustees may manage or supervise the management of any land or lands and premises for the time being comprised in the Trust Estate or any parts thereof erect, pull down, re-build, add to, alter and repair houses and other buildings and to build drains and make roads and fences and otherwise to improve and to cultivate or causes to be cultivated all or any of the said lands, and premises and to insure houses and buildings against loss or damage by fire and or other risks or to let, lease, make allowance to arrange with tenants, agriculturists, and generally to deal with the said lands, and premises as they may deem fit in their absolute discretion.
17. The TRUSTEES may appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyors, Gomatos or other employees on salary/ target/ commission basis for the purpose of management and supervision of the Trust Estate, for collection of rents, effect and profits, for keeping the account and for records and for other purpose of the Trust. In addition to, the Trust pay leadership commission, gift or provide rewards as part of recognition of any achievement.
18. The Trustees may establish their office at such place or places and may change such places from time to time as they may think fit. The Trust may go for Joint Venture, Collaboration, and Amalgamation with any other NGO, Trust, Company or Firm of national and international level.

19. The Trustees may demise the immovable property or properties for the time being and from time to time belonging to the Trust either from year to years or on monthly tenancies at such rent and subjects to such covenants and conditions as they may think proper and accepts surrenders of lease and tenancies and generally manage the same in such manner as they think proper.
20. The Trustees shall have full power of compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the Trust Estate and or the Trust properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and or the Trust properties and to do all other acts and things fully and effectually without being liable or answerable for any bona-fide loss occasioned thereby.
21. The Trustees may join, cooperate, and amalgamate the Trusts created by these presents or any portion thereof with any Trust or and for managing the affair of the Trust or Institution having allied and or similar objects upon such terms as they may in their absolute discretion think fit.
22. The TRUSTEES may from time to time frame schemes and rules and regulations to carry out the object of the Trust and for managing the affairs of the Trust and otherwise for giving effect to the object and purposes of the Trust and to vary the same from time to time as the Trustees may in their discretion deem fit and proper.
23. The receipts granted by the TRUSTEES or any one or more of them for any money, stocks, funds, shares, securities or investments paid delivered or transferred to them in exercise of the Trust powers hereof shall effectually release and discharge the person or persons paying delivering or transferring the same there from being bound to see the application thereof or being answerable for the loss or misapplication thereof.
24. The TRUSTEES shall be entitled at their discretion from time to time to start, continue, abolish and restart any charity or charitable institutions, to impose any



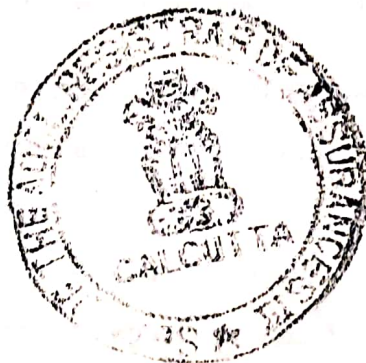

condition or conditions to any subscriptions or donation made by them and to earmark any portion of the Trust property or income for any particular object or objects.

25. The Trust may reimburse themselves and pay and discharge out of the Trust Fund all expenses incurred by them in or about the execution of the Trust or any of their duties under these presents including traveling expenses, but will not be entitled to any salary. The Trust may provide honorarium to the Trustees, to the designated Persons appointed by the Trustees, and to the Volunteers of the Trusts.
26. All the Trustees unless they voluntarily resign or otherwise decide shall continue to be the Trustees during the terms of their natural lives.
27. The number of Trustees shall not be less than two and not more than fifteen.
28. Any Trustee may retire at any time without assigning any reason and without being responsible for any cost occasioned by such retirement. Any Trustee may nominate his representative at the time of retirement and in such a case, The Nominee will have to accept by all other existing Trustees unless the Nominee is convicted by any Court of Law in charge of criminal offence. The Founder Members of this Trust is a permanent Body. In case of a normal or abnormal death of any Trustee, his/her nominee will take his/her charge and be appointed as a Trustee automatically by these present.
29. The surviving or continuing TRUSTEES may notwithstanding any vacancy in their board act as TRUSTEES PROVIDED HOWEVER that if the number of TRUSTEES shall fall below two, the minimum fixed by these presents the Trustees shall not, except for the purpose of filling any vacancy, act so long as the number is below the said minimum.
30. One third Trustees at a meeting shall form a quorum for any meeting of the trustees.
31. The TRUSTEES from time to time being shall elected from amongst them one

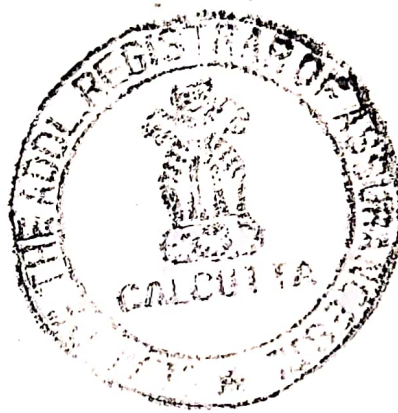

32. 33. 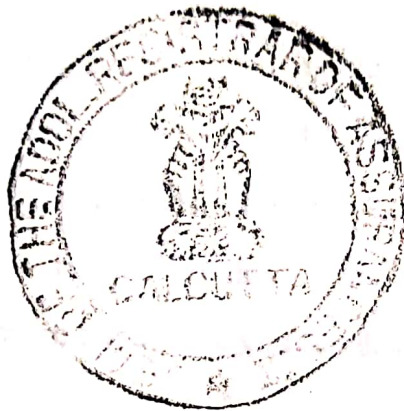

39. No person being - (i) An undercharged insolvent, or (ii) Convicted of an offence involving moral turpitude, or (iii) of unsound mind, or, (iv) A minor, shall not be eligible to be a Trustee.
40. The power to appoint new or additional TRUSTEES, but so as not be exceeded the maximum number and to fill vacancies in the of the TRUSTEES, shall vest in the continuing or Trustees.

46. The Board of TRUSTEES may, by a unanimous vote of all the TRUSTEES for the time being except the Trustees proposed to be removed, remove any Trustee, permanent or otherwise, from office after finding the Trustee, proposed to be



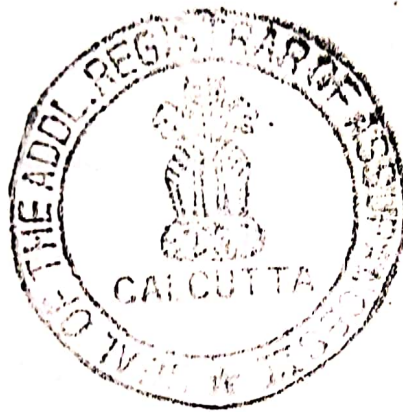
